Rule 1.200 Format of Citations Citations to cases and other authorities in all documents filed in the courts must be in the style established by either the California Style Manual or The Bluebook: A Uniform System of Citation, at the option of the party filing the document. The same style must be used consistently throughout the document.

Therefore, California statutory code citations merely include an abbreviation for the specific code followed by the number of the section being cited to (e.g., Cal. Civ.
