Florida Statute § 725.06 dictates that an indemnity obligation in a contract for or in connection with "any construction of a building, structure, appurtenance, or appliance, including moving and excavating associated therewith" that seeks to protect a party from its own fault is void as against public policy unless the contract complies with certain statutory requirements including a "monetary limitation" on any indemnification provision within the contract.
